- Questions posed regarding the Solicitation and their respective answers by The Citadel.

Questions:

- 1. since responses to questions will not be posted until possibly February 25th we are requesting an extension until close of business on March 14th
- A. Please refer to other changes listed below.
- 2. If necessary can we have the opportunity to revise your Terms and Conditions?
- A. This may be possible after an award is issued.
- 3. we are requesting the approval to present our pricing in a different format with added lines?
- A. Please do not submit any other pricing.
- 4. Can we submit additional offers?
- A. Yes, following the same price schedule.
- 5. We need to understand how we need to price the line item listing different sizes of drums on the same line item?
- A. Please see revised price schedule.
- 6. Can you confirm the exact number of accumulation areas across the campus?
- A. Currently, there are three however this may change as The Citadel's needs change.
- 7. How frequently does each area generate waste, and what volume typically triggers a pickup request?
- A. Generally, there are four to five requested pick-ups annually based on generation. Needs will vary based on on-campus activities.
- 8. Can you verify the exact composition of the liquid used with animal specimens (Carosafe) and confirm if it is indeed under 5%?
- A. Carosafe solution is less than 5%.
- 9. Can you provide more details on the types of chemicals stored in the lab accumulation areas?

Are there any mercury- or arsenic-containing materials?

Does the chemistry department have any reactive metals (sodium, lithium, potassium, Na/K alloy)?

- A. There are no mercury or arsenic containing materials and there are no reactive metals.
- 10. Would The Citadel require any replacement supply items for bulk wastes or mixed infectious hazardous waste (MIHW)?
- A. Containers may be required as requested.
- 11. The Pre-Proposal states that land disposal is not allowed—if there is no other disposal option, can these be treated under a CBC exemption?
- A. All material must be disposed of per local, state and federal requirements.
- 12. Will there be a requirement for additional permits or compliance documentation upon contract award?
- A. No. Vendor shall have all required licenses and permits required for disposing of materials picked-up.
- 13. Are there any specific labeling or formatting requirements for the thumb drive submission?
- A. No
- 14. Can you confirm that SC Resident Vendors receive a 2% price forgiveness, and does this apply across all cost categories?

A. All containers would be certain to conform to any DOT requirements.

- A. No
- 17. Can the Citadel provide a map of the campus with the locations of all pickup points?
- A. Yes, after an award is made.

20. During the pre-proposal conference it was stated that all materials for disposal would be packaged and ready for transport. On page 17, section 3, subsection 1.5 it stats that the contractor will be required to pack the waste as well. Will the contactor be responsible for the packaging of all lab pack chemicals? Or will The Citadel be held responsible for the packaging requirements of Hazardous and Non-Hazardous waste?

A. Materials will be packaged and stored for removal, however the vendor will be responsible for any additional packaging required for proper removal and transport.

21. If the Citadel packages the materials for disposal, will the contractor be given a packing list for the materials? Along with a Shipping name for the manifest? Or will the contractor be required to make the packing list for the container?

A. Yes, The Citadel will provide a list of the materials provided for disposal. Vendor shall be required to create any manifest required for transportation and disposal.

- 22. Is there no way to submit this bid online? It must be mailed?
- A. There is no other way to submit a response electronically other than including a thumb drive with a hard copy.
- 22. Also, line 21 of the bid schedule, what size containers will this biological waste be in? What types of specimens are they?
- A. Biological waste will be placed in a drum, individually bagged and small animals.
