¹ **South Carolina driver's license must be obtained within 45 days and South Carolina vehicle registration within 45 days of establishing intent to become a resident. Failure to do so will delay the beginning date of eligibility until both documents are obtained.**

² **Note that a South Carolina driver's license must be issued at least one year prior to the term in which you are applying for residency, unless you are applying under either the full-time employment or retired person provision.**

³ **If full-time, please attach a verification letter from your employer. The letter must be on letterhead stationery and needs to state: (a) the effective date of your employment in South Carolina, (b) that such employment is on a full-time basis (37.5 hours), and (c) the number of hours you work per week.**

⁴ **Persons who are self-employed should submit a copy of their South Carolina business license.**

- ❖ Owning property by itself does not allow a student to receive in-state tuition, as the other requirements still must be met. For parent(s) or spouse of dependent students, South Carolina must be the primary state of residence. Simply owning property is not sufficient.
- ❖ On-campus housing is considered temporary because you must be a student to live in it. As a result, you may not use on-campus housing to prove in-state residency.
- ❖ Resident status may not be acquired by an applicant or student while residing in South Carolina for the primary purpose of enrollment in an institution of for access to state supported programs designed to serve South Carolina residents.
